

Cancer Care Beacon - Reducing Disparities Across the European Union (BEACON)

Summary of the project

The **Cancer Care Beacon project** is a EU4Health-funded project aimed at identifying and then reducing disparities in cancer care across Europe. Existing disparities in cancer screening, diagnosis, treatment, quality of life, management of survivorship, and palliative care at the end of life raise a series of challenges within and across Europe. The **BEACON** project will explore such challenges by mapping existing oncology data and by investigating reasons for disparities in cancer care. Cancer Care Beacon aims to create a list of cancer databases from all OECI Cancer Centres in the EU and their corresponding countries. The mapping of EU Cancer Treatment Capacity and Capability in the Member States is expected to result in facilitating the delivery of higher-quality care and reduce inequalities across the European Union.

Objectives

Specifically, BEACON is aimed at:

- (1) mapping and improving the capacity and capability of cancer centres across the European Union;
- (2) creating decision support tools that will assist our four stakeholders: *patients* in finding the best cancer centres, *providers* in sharing resources and expertise, *researchers* in sharing data, and *policymakers* in aligning funding allocation with patients' priorities;
- (3) getting training and accreditation to reflect the quality of cancer care.

Expected results

We will gather information on each stakeholder's needs (i.e., patients, providers, researchers, policymakers), we will map existing oncology data across Europe and we will create a website named "**Cancer Care BEACON Wiki**" to allow our stakeholders to search, explore, evaluate, revise, generate, and update cancer information. The Wiki repository will store all public information about Cancer Centres and their countries and will be displayed in all official EU
